Malaria and Malnutrition are the major causes of sickness that greatly contributes to absenteeism and poor performance by pupils and teachers in schools.

Place(s) in which the project will be carried out	Basing on mortality statistics as a result of Malaria and malnutrition in Uganda, it's obvious that the whole country needs to be rescued from those dangers which are especially prevalent among children. Therefore, we would intend to make the project a national issue, but this will be determined by the financial support to the organization. Specifically, the project will be initially implemented in the following 5 districts: Luweero, Masaka, Mpigi, Kiboga and Mubende.

### 2.3 Detailed description of the project content.

The project consists in developing fruit growing and malaria control techniques in community-based primary schools so as to improve the pupils' health conditions and thereby the quality of education. The project is designed to provide a package of both *Artemisia annua* (to fight malaria) and fruit production plants in 5 needy primary schools of 5 districts of Uganda.

Massive sensitisation of the community will be undertaken at the early stage and throughout the project to raise awareness among the communities about the project goals, benefits and implementation.

The Artemisia seeds will be supplied by IDAY-International while fruit seeds will be procured by the implementing organisation (EACDA) with the funds from the donor. Both Artemisia and

fruit production seeds will be germinated, transplanted and replanted in the schools participating in the project following the specific guidelines of both IDAY-International and National Agricultural Research Organisation (NARO). The guidelines will be strictly followed by the organisation consultant who will be fully responsible for all the seedlings in the nursery beds.

With *Artemisia annua*, special care will be given to demonstrate to the communities the practical way of how it can be used by them to combat malaria scourge in schools and beyond. The seedlings will be delivered to schools using safe packing boxes. The implementing organisation will make follow ups to monitor the progress of the seedlings.

The implementing organisation will strongly work hand in hand with the established community committees that will help to monitor and supervise the replanted seedlings at all levels of growth.

In order to make the impact of the project felt and appreciated countrywide as a basis of value addition to improving life and performance of the pupils including the community where these pupils live, several media houses will be lobbied for effective publicity of the project activities.

- To improve comprehensive early childhood education for the most vulnerable and disadvantaged children in the target rural areas and suburbs of urban centres by year 2015.

- To potentially reduce on high levels of Malaria incidences and the associated high costs of treatment by use of Artemisia.
- To improve on nutrition levels of the primary going children and the community in general in remote areas.

About 3,054 primary school children in 5 primary schools in the 5 districts will be the initial beneficiaries of the project. The selection criteria of the beneficiary school will be based on the level of deprivation.

The parents, teachers and the nearby communities in the districts where these schools are located will be the secondary beneficiaries.

## 2.7 Specific questions

### 2.7.1 What is the view of the governmental authorities on the project?

Malaria is a major cause of mortality especially among the children between the age of 1 to 12 years and the pregnant mothers in Uganda. The recent facts about malaria show that Malaria accounts for 70,000-110,000 child deaths annually in Uganda.

Malaria accounts for 40% of Ugandan public health expenditure, 30-50% of inpatient admissions, and up to 50% of outpatient visits in areas with high malaria transmission. The government therefore spends a bigger amount of money with an aim of improving the quality of life of people especially the poor who cannot afford to meet the cost of malaria treatment. Both the rich and poor benefit directly from malaria control programmes.

The organisation has implemented several projects in primary schools in its areas of operation that has even prompted line ministries to pledge possible support to the general objectives of the organisation in which this programme is inclusive. The Ministry of Health has also been contacted and has provided sufficient information that has been included in this project and also has pledged to offer technical support required if donation is given.

The sub committees on advocacy and publicity comprised of the District Education Officers (DEO's) from all districts where the schools are located are supportive in advocating for quality control of malaria and improved diet of their communities. The government has pledged to support EACDA for the credible and decisive impact it has had on child education as a way to achieve Education For All (EFA) goals. This project hence is in line with the principle of state policy of Poverty Eradication Action Plan (PEAP).

### ***2.7.2 How are students' parents involved and what is their contribution to the project?***

Although the Uganda Government Policy on education discourages the operation of Parents Teachers Associations (PTAs), the compromised The existing Parents and Teachers' Management Committees (PTMCs) play a crucial role in mobilization of resources for the school projects. The parents in the identified schools have committed themselves to offer support ranging from organic manure, hoes, barbed wires, supervision and required labour as inputs to this particular project. A fund has been instituted to raise money for the initial stages of this project. The challenge that lies ahead is that most of the parents in these selected schools are too poor to afford the minimum contribution required for kick starting the project.

### ***2.7.3 How are the young beneficiaries participating in the project and the organisation responsible for implementing it? (precondition for students from secondary or university levels)***

The pupils with help of teachers in the selected schools have been requested to provide water for watering seedlings once they are delivered, creating drama about consequences of malaria and malnutrition, creating artistic images about malnutrition, weeding the plants once planted.

### ***2.7.4. What measures have been or will be taken to ensure that the project will contribute to the maintenance or enhancement of the environment and be sustainable (no exploitation of non renewable resources at the expense of future generations, disposing of waste, ....)***

The project is aiming at planting trees that not only benefit the community through fruit and herb harvesting, but also greatly contribute to environment conservation and protection.

### ***2.7.5. What is the ratio girls/boys and how will the balance be guaranteed?***

The schools selected to benefit from the project were chosen on criteria of being a mixed school. The general ratio of girls/boys in the selected 5 schools is 5:3.

### ***2.7.6. What is the promoter's relationship with IDAY? What level of participation are you envisaging in its activities (date of the signature of the Charter or Memorandum of Partnership)***

EACDA is a member of IDAY-Uganda. This membership was undertaken to contribute to the achievement of the objectives fixed by the Dakar Framework and the second Millennium Development Goal (MDG). EACDA helps to organize the commemoration of the Day of the African child in favour of education in Africa to create a mass effect and in the achievement of the MDGs. We apply a strategy that attracts and retains children, with a focus on girls, who are presently dropping out of schools at a higher rate than boys especially in upper primary, with even smaller portions attaining higher education. EACDA is therefore strives to achieve the IDAY's objective of improving education through reducing on the time the children and teachers lose due to malaria incidences.

### ***3. HOW DO YOU INTEND TO IMPLEMENT THE PROJECT?***

#### ***3.1. Describe the various phases and the timing of implementation or development of the project.***

The project will be fully executed by the organization (EACDA). The project management committee comprised of; consultants from Botany, Medical consultants, District Education Officers representing the government, school teachers and parents, community leaders and representatives of IDAY-Uganda will oversee the project implementation.

Every two months, a project coordination meeting, chaired by the coordinator of the organization composed of the project management committee will sit. While the project secretariat at Kampala will be responsible for preparing the meetings, the meeting will handle the monitoring of the project in the primary schools. After the monthly reviews are undertaken in the 1 day meeting, a comprehensive review will be undertaken towards the end of the project period within the framework of the EACDA strategic plan.

The district committees will work under the coordination of the EACDA executive committee at that level. These will be responsible for planning, supervising, monitoring and reviewing all school project activities in the district with the support of the project management committee. Implementation of the project activities will call for close collaboration with a wide range of partners within government, civil society, the community, service providers and the donor community. This should enhance the opportunities for the realization of the broad goals and objectives of this project.

#### ***3.2. Describe the current status of the project***

The project has tentatively started. Source of good seeds have been identified, some seeds have been tested for germination and the period of growth have been established, school administration have been contacted, sensitisation about the project benefits to the prospective beneficiaries is under way. Stakeholders have been consulted and have shown greater interest in the project for example line ministries.

**4.3. Describe the framework or contract conditions for a possible financial partnership.**

Whereas the contracting authority (EACDA) desires to engage the services of the financial partner on the Terms and Conditions herein set forth, and whereas the financial partner is willing and ready to accept this engagement of services with EACDA on the said Terms and Conditions, the parties agree that the financial partnership shall accelerate the attainment of the project objectives.

**5. SUSTAINABILITY (ROADMAP TO FINANCIAL AUTONOMY of the PROJECT)**

Sustainability: fruit growing and *Artemisia annua* culture and use will become autonomous throughout the project, once the initial equipment is provided and the communities are informed and trained on how to maintain and use the plant for malaria control.

Community ownership: to ensure that this project achieves the highest level of sustainability, it will involve the community at all levels. The project implementation strategy will be used in close collaboration with community representatives, medical practitioners, line ministries, Agricultural consultants, youth groups, the project management committee that is composed of the District Education Officers representing government, the school teachers and parents and related associations, schools, community development resource persons, universities in the proximity and representatives of the IDAY-Uganda in order to ensure that the needs of the target group(s) in this project are fully represented.

**6. HOW DO YOU INTEND ON EVALUATING THE PROJECT?**

(quantitatively – qualitatively), method (participants' questionnaires, oral evaluation etc.)

**6.1. What are the evaluation criteria?**

Evaluation will be undertaken by the implementing body based on the information from various stakeholders and specific data that will be monitored throughout project implementation. This will help to assess the effectiveness and impact of the project.

Data will include:

- Evolution of the number of malaria incidences in primary schools where the project is implemented.
- Evolution of the number of days of absenteeism by pupils and teachers during school days.
- Evolution of enrolment for both boy and girl children.
- Evolution of school results and completion rates.
- Appreciation by teachers of pupils' attention in class and performances.
- Evolution of the communities' expenditures on malaria cases.
- Evolution of the communities' expenditures resulting from malnutrition.

### ***6.2. What is the timing?***

Monitoring will be undertaken bi-monthly. Evaluation will be undertaken every three months.

### ***6.3. Which evaluation method(s) do you intend using?***

Data for evaluation will be collected through follow ups, interviews, pre and post malaria records and other methods that will seem convenient. The information will be basically generated from various stakeholders and beneficiaries.

### ***6.4. Should the need arise, how do you intend ensuring the continuity of the project?***

To ensure that this project achieves the highest level of sustainability and continuity, it will involve various potential stakeholders mentioned in 4 above. These stakeholders will help to mobilise resources if there is a need for the continuity of the programme. The mobilised resources from those stakeholders will help to distribute the harvested seeds produced by the beneficiary schools in those districts, thus replicating the same project benefits.

### ***6.5. How will the results of the project be published, communicated, monitored?***

Efficient means of information dissemination will be employed to ensure that the results of the project reach a wider coverage in the country and to international stakeholders. Media houses such as television, print media, radio stations, network assemblies and on commemoration days. To efficiently monitor the results of the project, a special committee will be appointed in each school to ensure feed back mechanism to the implementing organisation during and after the implementation of the project. At the end of the project period, a report will be made and distributed to all stakeholders.

- A percentage reduction in malaria incidences in primary schools where the project will be implemented.
- A percentage reduction in absenteeism by pupils and teachers during school days.
- A considerable reduction in expenditures by communities on malaria cases and those cases that result from malnutrition.
